Remove all plastic/vinyl covers from pillows and mattresses. Baby crib and sickroom mattresses must be removed. ☐ 9. Cut back shrubs and tree branches adjacent to the structure to prevent damage to them. Thoroughly water the ground around shrubs and plants. Rocks, gravel, mulch or wood chips must be raked 12-18 inches away from the structure to ensure a proper ground seal. ☐ 10. Automobiles, boats, vehicles of any kind, patio furniture and patio ornaments must be placed, by owner, at least 30 feet away from the structure being tented to prevent any potential damage due to tenting equipment falling from roof. Darn Quick Termite & Fumigation, will not be held responsible for damage, if these items have not been removed.	 □ 19. In the case of adverse weather conditions, (wind, rain, storm) the job may need to be rescheduled. □ 20. Power Lines, Telephone Lines, T.V. Cable Lines, should be in good condition.
